Please contact your buyer if the freight to be tendered is outside the capabilities of the companies listed below.)

*Unless otherwise directed by NORDAM Purchase Order and /or written authorization from the NORDAM buyer, Shipper is responsible for selecting the **most economical shipping method** based on the freight’s physical requirements (weight, dims, time sensitive {dry ice}, etc.) and transit time. 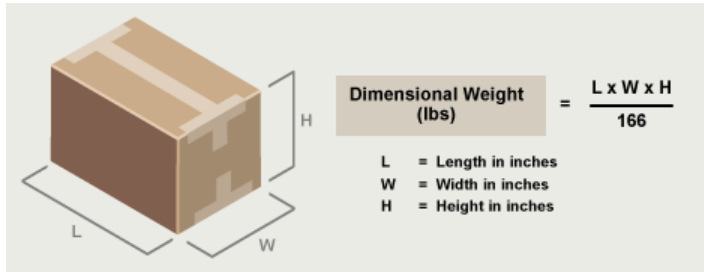

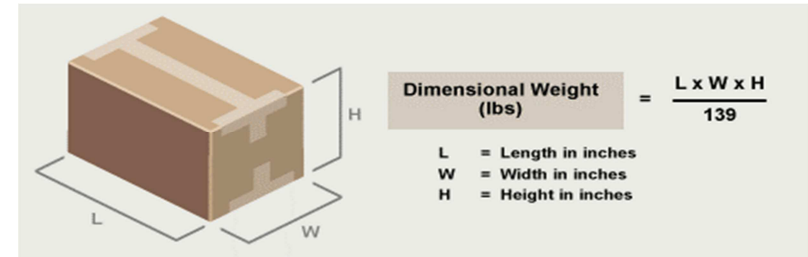

Packaging / Size & Weight Guidelines

Determine Dimensional Weight – for *Domestic Ground* Shipments**



Determine Dimensional Weight – for *International* Shipments**



Determine Dimensional Weight – *LTL* Shipments**



Length + 2x Width + 2x Height

Step 1 – Determine Length (measure the longest side of the package)

Step 2 – Determine Girth (2x Width + 2X Height)

Step 3 – Add the Length to the total Width and total Height = DIM Weight

Length – 12.5"

Width – 12.5" x 2 = 25"

Height – 6.25" x 2 = 12.5"

Package Measurement – 12.5" + 25" + 12.5" = 50" this package could be shipped Ground

Effective June 6, 2016: Any package with the longest side exceeding 48” will be assessed an additional handling fee. The current rule when a package’s second longest side exceeds 30” is assessed a \$10.50 handling fee is not changing

Nacelle / Thrust Reverser Systems Division Packaging Guidelines

It is the responsibility of the supplier to insure that all items are packaged and shipped properly using the following as a guideline:

- ✓ Each part/item will be clearly identified and packaged
- ✓ Parts are to be packaged with paper layers and /or individually in bags. No metal to metal contact will be accepted. This also applies to items made from other materials
- ✓ The supplier shall package shipments of multiple line items in quantities not to exceed the quantity ordered per line item on the purchase order
- ✓ Each line item shall be packaged separately
- ✓ Proper and appropriate containers shall be used to prevent damage to packaged parts, and in accordance with the International Plant Protection Convention (IPPC) for Wood Packaging Materials (WPM)
- ✓ Proper and appropriate dunnage is to be used as cushioning to prevent shifting of parts and damage in transit
- ✓ Parts outside the weight and dimension limit for UPS or FedEx (see above in the NORDAM Transportation Guide) need to be shipped in something other cardboard box to prevent damage
- ✓ Shipments over 75 pounds should be divided into multiple containers or secured and shipped on a pallet in such a manner that shall prevent damage
- ✓ The supplier shall include with each shipment, all documentation required by the applicable purchase order and the NORDAM Supplier Quality Manual. All documents shall be accurate, legible and in English
- ✓

These guidelines do not relieve the supplier of the responsibility for properly controlling the packaging and shipping function in a manner that prevents damage in handling and in transit. Shipments arriving not in accordance with the above, or with obviously inadequate packaging, are subject to rejection and return, at the cost of the supplier.
